Transport Operations (Marine Safety) Act 1994

This form may be used to apply for—

- a Recreational Marine Driver licence;
- a Personal Watercraft (PWC) licence; or
- a Confirmation Report stating that you are the holder of a current Recreational Marine Driver and/or Personal Watercraft licence.

To apply for a Recreational Marine Driver licence, you must be at least sixteen (16) years of age or older and be able to produce evidence that

- successfully completed a Department of Transport and Main Roads (the department) approved course of training/assessment; or
- a current interstate recreational marine licence.

To apply for a Personal Watercraft licence, you **must** be at least sixteen (16) years of age or older, hold a valid Recreational Marine Driver licence or recognised equivalent marine licence and be able to produce evidence that you have-

- successfully completed a Department of Transport and Main Roads (the department) approved course of training/assessment; or
- a current interstate Personal Watercraft licence that is recognised in Oueensland.

Evidence of identity (EOI) requirements

You **must** give evidence of your identity at the time of making this application. If you do not have a Queensland driver licence (current or expired less than 2 years), you must show at least three (3) EOI documents.

These documents must include at least one Category A and at least one Category B document. The third document may be from either category, however, one of these documents must include your signature.

If you have changed your name or the details of your name are different on the documents provided, you must show a change of name document from the relevant Registrar of Births, Deaths and Marriages.

Photocopies and certified copies of original documents are not acceptable. All documents must be current unless otherwise stated. Please refer to the Evidence of Identity Information Sheet (F4362) or the department's website www.transportandmainroads.qld.gov.au for a full list of EOI, and change of name documents.
